### What is this product?

#### Type

The Trust is an investment company as defined in Section 833 of the Companies Act 2006 and operates as an investment trust in accordance with Section 1158 of the Corporation Tax Act 2010. The Company is subject to the UK Listing Authority Rules.

#### Objectives

To seek income and capital growth such that the total return on the net asset value of the Company exceeds the average return on a rolling basis of three month sterling LIBOR plus 2 per cent. The Company invests in a diversified portfolio of global fixed and floating rate income asset classes including secured loans, government bonds, high yield (sub-investment grade) corporate bonds, unrated corporate bonds, investment grade corporate bonds and asset backed securities. It may also invest in high yielding equities. The Company's investments can be in assets of any size, sector, currency or issued in any country. Financial assets known as derivatives can also be used to enhance returns, reduce risk or manage the Company's assets more efficiently. The Company may also employ financial gearing for efficient portfolio management and to enhance investment returns.

#### Intended retail investor

Investors (retail, professional and eligible counterparties) with at least basic capital markets knowledge or experience of shares, who understand the Trust's risks, are seeking income and capital growth from fixed and floating rate asset classes, and intend to invest their money for at least five years. This Trust is designed to be used only as a component in a diversified investment portfolio and is not designed for investors who are unable to accept more than a minimal loss of their investment.

#### Terms of the PRIIP

This investment has no maturity date. There are no circumstances under which Janus Henderson would be entitled to terminate the Company unilaterally. There are no circumstances under which the Company can be automatically terminated.
