What is this product?

Type

The Trust is an investment company as defined in Section 833 of the Companies Act 2006 and operates as an investment trust in accordance with Section 1158 of the Corporation Tax Act 2010. The Company is subject to the UK Listing Authority Rules.

Objectives

To maximise shareholder total returns (capital and income) by investing in smaller companies that are quoted in the United Kingdom. Smaller companies are defined as those outside the FTSE 100 index. Investments may include shares, securities and related financial instruments, including derivatives for the purposes of efficient portfolio management. Net gearing is limited to 30% of shareholders' funds.

Intended retail investor

Investors (retail, professional and eligible counterparties) with at least basic capital markets knowledge or experience of shares, who understand the Trust's risks, seeking growth mainly from smaller companies in the UK, and intend to invest their money for at least five years. This Trust is designed to be used only as a component in a diversified investment portfolio and is not designed for investors who are unable to accept more than a minimal loss of their investment.

Terms of the PRIIP

This investment has no maturity date. There are no circumstances under which Janus Henderson would be entitled to terminate the Company unilaterally. There are no circumstances under which the Company can be automatically terminated.
