Fund aim

The Fund aims to provide a total return (capital growth with income) by investing in a broad range of bonds and related derivatives of any issuer in any country. The Fund will take strategic asset allocation decisions between countries, asset classes, sectors and credit ratings. The Fund may also invest in preference shares, contingent convertible bonds (bonds that, upon a predetermined 'trigger event', can be converted into shares, or are partly or wholly written off), loans and equities. The Fund may use derivatives, including total return swaps (derivatives whereby one party pays/receives the total return of an underlying asset or market index, in exchange for payments typically linked to LIBOR), towards achieving the Fund's investment objective, to reduce risk or to manage the Fund more efficiently.

This is a Luxembourg SICAV Fund, regulated by the Commission de Surveillance du Secteur Financier (CSSF).

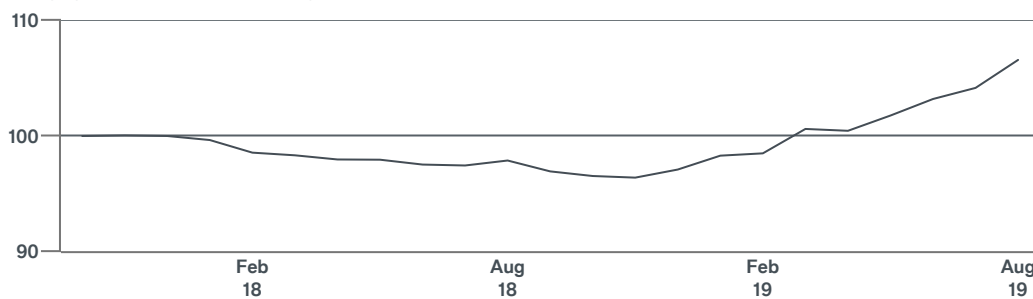
