**Removal of the performance fee for certain funds of the Company**

Dear Shareholder,

We are writing to you as a Shareholder of the Janus Henderson Horizon Fund – Euro Corporate Bond Fund, Janus Henderson Horizon Fund – Global High Yield Bond Fund, Janus Henderson Horizon Fund – Euro High Yield Bond Fund and Janus Henderson Horizon Fund – Emerging Market Corporate Bond Fund (the **Funds**) to inform you that the Performance Fee of the Funds has been removed from 1 July 2019.

All other key features of the Funds remain the same. The ISIN codes of the share classes of the Funds impacted by this change are listed in Appendix 1 of this letter.

We confirm that in respect of this change:

- the Funds will continue to be managed in a manner which is in accordance with their existing investment objective and policy;
- the investment objective and policy and the risk profiles of each Fund will remain the same;
- the costs and expenses incurred in connection with this change will be borne by Henderson Global Investors Limited, the Investment Manager of the Funds;
- there will be no increase to the existing fees or charges borne by the Funds as disclosed in the Prospectus; and
- there will not be any matters/impact arising from this change which may materially prejudice the existing investors' rights or interests.


