## **Renaming of existing distribution share classes of certain funds (“Funds”) of the Company**

Dear Shareholder,

We are writing to you as a Shareholder of certain existing distribution share classes of the Company (“Distribution Share Classes”) to inform you that they will be renamed from “Sub-Class 1” to “Sub-Class 3” from **1 November 2015**. Please see the attached annex to this shareholder notice for details of the Distribution Share Classes that are impacted.

Your Distribution Share Classes currently distribute substantially all investment income before deduction of fees, charges and expenses, and there is no change to this policy as a result of the renaming exercise.

### **Why are we making this change?**

In the future, we may wish to introduce new distribution share classes with different distribution policies. As a result, the Directors have resolved to rename your Distribution Share Classes, as described above, as “Sub-Class 3 Shares”. There will be no change to the way in which your distribution is calculated or received.

### **Action to be taken**

If you agree with the proposed changes, you need take no action.

If you do not agree with the proposed changes, you can sell or switch your Shares in the Fund free of charge on any date up to **30 October 2015** for the changes mentioned above, in accordance with the provisions of the Prospectus. Please note in circumstances that the Directors consider appropriate, a Trading Fee (on redemptions made within 90 days of purchase) or dilution adjustment (to reflect more fairly the value of the investments in the circumstances) may be applied, in accordance with the provisions of the Prospectus which may lower the value of your redemption proceeds.

We will normally make payment in accordance with the standing instructions we hold on file. If you have changed your bank account and not informed us, please confirm your up-to-date details in writing to RBC Investor Services Bank S.A. at the address provided above.

If you choose to switch your Shares to a holding in a different sub-fund, we will use the proceeds to purchase shares in the sub-fund(s) you specify at the share price applicable to that sub-fund in accordance with the provisions of the Prospectus.
